1. Number of main sessions

- In determining the number of main sessions we needed clarity on the BPFs and ISOCs proposal whether they impact on the numbers and the scheduling
- A track for emerging issues is probably not necessarily as they are already included in the work
- Determining the influence of the thematic tracks on the main session should we have main sessions determined by thematic tracks.
- The value of thematic (track) main sessions would advantage access to interpretation which allows for diversity in participation and providing an overview of the main tracks.
- Looking at the main session with a design to maintain the interactivity through breakout groups which would combine topping and tailing
- The value of topping and tailing were meant to support/replace the beginners (newcomers) sessions and had the break out value
- Working on asynchronous approach with an offline approach to following the information that is being done and we have a tailing session to conclude what has been covered in the thematic track
- We still think the Newcomers main session is important to stay Mary, have I understood this correctly?

2. Topics for main sessions, e.g.

- Themes from the thematic tracks. Environment was emphasised during the discussion
 - Thematic tracks should have an influence the main sessions
- Roberto and Karim's proposal

- This proposal may be a good candidate to represent the inclusion group but would need consultation with the inclusion group to decide whether to count this as a main session or depending on the number of main sessions this is considered as a standalone main session.
- There is a need for more context on this session as it may be focused more on business models and may need to stand alone or be linked to the emerging issues panel
- Things to consider going forward should this be for the inclusion group to discuss or should there be a broader conversation ie does it stand alone or become an overlap with emerging issues
- Data track's proposal
 - Expanding the suggested track to be more diverse and draw on other sub-themes.
 - It is suggested maintaining workshop 229 but draw some of the insights and questions then design the session to be inclusive and draw in other topics.
- Open consultation proposals (Digital cooperation, pandemic, emerging policy issues)
 - The community sees the HLPDC roadmap as valuable for a main session, especially 5A/B part of the recommendations
 - However there is a need to look at the content of the emerging issues main session content as they may already be included in other main sessions
 - Recommendation that this session rather focus on the recommendations as it adds more value to the overall IGF space
- Dynamic coalition proposal
 - Support for the one main session
- NRI proposal
 - Support for the one main session
- 3. Introductory and concluding sessions for tracks.
 - We support continuation of those two sessions with some innovations by the facilitators,

- Try not to have schedule overlap with Main sessions or important sessions. Breakout discussions can be done on language groupings
- The concluding should not overlap with other workshops depending on the design to be adopted for the vIGF
- 4. Thoughts on IGF2020 opening and closing (which is likely to be managed by the UN as the former 'host' of IGF 2020)
 - Do we want to have any say on the main sessions as hosted by the UN -
 - Just to make it as interesting as possible to keep the audience as long as it lasts. The UN can share the Agenda beforehand with the MAG.
 - This is the usual opening ceremony.
 - Request the UNSG to appear live and not pre-record his address
 - Make sure that open mic will be maintained during the final session but then think of the process thinking of different formats either taped, recorded or put in a text format. Then have the session pre-recorded in response?
 - o Pre-recording and text format will save time and accommodate many speakers.
- 5. Next steps for working on main session planning
- groups, how many, how to constitute them
 - Having as many groups as the Main sessions accommodated in the programme to further develop the sessions (as we had in previous years)
 - Important to have all MAG members involved in facilitation and/or moderation of (at least one) Main session, call for volunteers to facilitate each session with a limit on the number of Main Sessions each MAG member can effectively participate in facilitating
 - Responding to the pandemics the sessions are advised to consider the pandemic in the way they plan the questions to be covered

- Thinking on how to enhance interactivity (having an open online document for gathering the inputs from the community during the session, pre-recorded questions, ..)
- Duration of main session between 90 and 120 minutes
- Try not to have overlap between main sessions and opening and concluding sessions
