Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #94 | 12 February 2025

Summary Report

The participants of the Dynamic Coalition Coordination Group (DCCG) Meeting #94 focused on organizing Dynamic Coalitions (DCs) for an upcoming IGF, aligning them with MAG priorities and host country clusters. Discussions revolved around technical issues, agenda adoption, session proposals, and the need for DCs to indicate their preferred clusters. The participants agreed to send out a note to the DC list for reclassification, postpone other agenda items, and schedule a follow-up meeting to further discuss the changes.

I. Adoption of the draft agenda

The agenda of the DCCG meeting #93 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

II. Outcomes of the First IGF Open Consultations and MAG Meeting.

The MAG Chair reported on the recent meetings, highlighting the IGF 2025 theme and sub-themes, the need to strengthen collaborations between DCs, NRIs, and the MAG, and the importance of incorporating feedback from DCs and NRIs. The importance of having a MAG liaison to attend DC coordination meetings was emphasized. Participants discussed the upcoming call for workshop and session proposals, encouraging DCs to merge proposals and submit them together. They also discussed the need for a more direct link between workshop proposals and intersessional work, and the possibility of presenting outcomes at the IGF. The meeting revolved around the organization of sessions for a future event. There was a discussion whether to align with the official clusters approved by the MAG, which included building digital trust and resilience, sustainable and responsible innovation, universal access and digital rights, and digital cooperation or whether to stick to the clusters from the previous year. A concern was raised about the SDGs not being evenly distributed among the focus areas. It was suggested giving participants an option to choose their preferred thematic areas and the importance of accessibility was emphasized as well as the need for a two-step approach in deciding the best fit for each dynamic coalition.

The participants agreed on the need for a flexible approach to groupings, allowing for participation in multiple clusters as needed. The importance of aligning their work with the GDC, WISS and the SDGs and the need to showcase their contributions to these processes was also emphasized. The meeting also acknowledged the need for a long-term view in their planning, considering the strategic benefits of groupings and potential synergies among DCs.

The meeting discussed concerns about the clarity of goals for the DC, with the GDC as their possible benchmark. There was general agreement for the DCs to shift away from last year's clusters and align themselves with the four tracks created by the MAG, which consider the GDC, the WSIS action lines, and the SDGs.

It was suggested that the DCs should be given time to analyze where they fit best and have time to consult their members before deciding. The conversation ended with a decision to give the DCs until the end of the week to make their decisions.

The meeting agreed that the GDC would propose to the MAG to have four sessions under the headings defined by the MAG, and a Main session. Due to time constraints the meeting was unable to address the other agenda items. It was therefore decided to have another DCCG meeting the following week to assess the clustering and to address other agenda items.

Next Steps

1. Dynamic Coalition coordinators to decide which cluster(s) their DC belongs to by Friday close of business.
2. Co-facilitators and IGF Secretariat to prepare and send out a summary and survey to DCs about the new clustering approach.
3. Rajendra to adjust the planned webinar to align with the new clusters.
4. IGF Secretariat to send out a Doodle poll for scheduling next week's DC coordination meeting.
5. DC members to add their DC affiliation to their Zoom names for future meetings.
6. DC coordinators to review the themes and sub-themes posted on the IGF website.
